## Contents of a Letter Sent to World Leaders

No man knows more than you the difficulties of reconciling the state of Israel to your world.

We offer a new approach to dealing with this situation if you have time to consider it. This approach is summarized in the contents of a letter sent to other leaders of your world and other interested parties, as follows:

We have summarized the Plan in a small book enclosed. The Plan uses Biblical Solutions designed to meet Biblical (prophesied) problems. Israel's restoration to the Holy Land is such a prophesied problem for those who occupied the land beforehand. For this problem there is not only an acknowledgment in Scripture but also a solution! We discuss the solution in our book.

While you at first may not like the principal precept of the plan, we know that once you review all the arguments of our book you will agree that the solution we have derived is the most logical and expedient of all alternatives reviewed or tried thus far.

While there are many considerations and many opposing interests in your part of the world, all of you have one thing in common: you allow yourselves to be guided by the Bible. Your nations were created by the Bible and are governed by the Bible. Thus, when it comes to negotiation of your problems you can all search scripture for guidance and needed solutions. The Scriptures are a tool which can help you negotiate a settlement with Israel.

Israel has expressed interest in negotiating with each of the Moslem nations on an individual basis. Our plan is not affected by this procedure.

Our Plan is based upon four principles and two concessions:

1. The Koran derives its authority from the Old Testament Scriptures: the Torah and the prophets. Therefore, all of you are bound to uphold the Solutions proposed for these times by the Torah and its prophets. Moslems and Jews alike—if they are blessed by the Bible—must uphold these truths.

2. When the Children of Israel are restored to the Holy Land, the Bible says the Temple will also be restored, and Isaiah says all nations shall come and build it and worship in it. It shall be known as a *House of Prayer for all peoples* (not a house of sacrifice). The Jews, of course, have been waiting to build this house. Our plan accommodates their expectation but with one small twist. The prophecies say that Moslems—and other peoples—have as much an interest and right in that building as the Jews. Its placement and design is as much a Moslem decision as a Jewish decision. Scripture upholds this point of view.

3. When the Children of Israel are restored to the Holy Land the prophecies say that all those living in Jerusalem—even all those living there in that day—will be called Holy. This means that Palestinians and Christians will also be viewed as Holy to God. Furthermore, connected with this Promise is the statement that when the Temple is built many nations will be joined to God in that day. This means that there is no one Chosen People at that time. It follows that The Messiah who is welcomed through the Golden Gate in Jerusalem is the Messiah of all those peoples joined to God and His Temple.



4. When the Children of Israel are restored to the Holy Land the prophecies say that the Land will be given a **New Name**. This becomes a key element of our Solution. The Temple becomes a focus—a building—by which all those living in Jerusalem can participate in a united effort demonstrating a willingness to live and worship together in the same house. The Temple does not supplant any other house. It merely becomes a house open to all peoples who seek God in that day.

The **New Name** is important, for it provides a **New Identity** for the State of those people living in the Holy Land when the Temple is built. **The New Identity must take into consideration all peoples of the land and deal with them equitably.** This in turn promises the consummation of a **New Law** for the Holy Land. Thus, Palestinians are assured full rights under that **New Law**. And you—if you are joined to God on these **Two Concessions of the Temple and the New Law**—have a right to participate in the formation of that **New Law**.

These four principles of a New Nation were not created by this writer but are clearly spelled out in the **Contract** of the Old Testament. We suggest that each nation in the area ought to sit down with Israel and ask for only these **Two Concessions** to make Peace in the area:

- The concession to initiate building the Temple immediately, with the Moslems holding the right to also overview its design and construction—to assure it meets the requirements specified in the Scriptures.

We have proposed building the Temple close to the Dome of the Rock. When you examine our reason for the Temple's placement within the location specified you will agree on its placement. See Figure 1 of the enclosed book. Figure 1 records a map of Jerusalem before it was destroyed. The map is probably dated by the comet (Halley's Comet) drawn in it, making the date of that map circa. 66 A.D. Thus, Figure 1 is the most reliable evidence of the original location of the Temple; and it places the Temple about the temple's length away from the Dome of the Rock. Note that the Dome itself is centered over the highest peak of the mount.

- The concession to rename the Holy Land according to the criteria established by Isaiah: reasons as noted in the enclosed book.

**Israel is compelled by their scriptures to agree to the above concessions.** They base their right to dwell in the land (and occupy the West Bank) based upon Scripture. They cannot, then, deny the two small concessions in Scripture mentioned above which go along with the other Promises made to Israel.

The enclosed small book is part of a 9 volume series dealing with this subject. We can support our conclusions with over two thousand pages of Biblical precepts.

If you follow the advise of this little book we believe many of the problems you have in your area will go away. We have sent the book to other leaders in your area and hope that one day you might meet together to discuss it and use it.

Dear Secretary-General Ghali,

*When you take office in January 1992 we ask that you hear our plea...*

On several occasions we submitted a plea to former Secretary-General Pérez de Cuéllar and other leaders (see list below) and failed to not only gain a reaction but also a reply.

*Noting that President Bush, Secretary of State Baker and the former Secretary-General have had miserable failures in forging a solution to the problems in the Middle East;*

*noting that you among only a few men in this world (because of your work in the Camp David agreements) understand the precedents affecting the negotiations;*

*we ask you to review the enclosed Contract and its supporting documents which carries a plan which will bring you success where others have failed.*

You will know from your review of the enclosed documents that no one knows the issues better than I. The issues involve International Law, Economics, the Torah and its prophets (the Bible and the Koran), and the *integrity of the United Nations* who is to date still the only *legal owner of Jerusalem*. Your wise men will confirm me. Perhaps you recall Isaiah's promise: that Saviors for this time will come out of Egypt.

*Noting that what is done in the future Middle East talks will set a precedent for future generations, we ask that you seriously consider our Contract for the Middle East, as opposed to those propositions (based upon power and greed) from the leaders [sic. President Bush et al.] now trying to muscle the negotiations.*

We write from the perspective of the *heirs (Aliflam ra)* and say to all the men we listed below that their plans will not succeed and will fail. Because of our perspective we hope that you will note that a movement is going forth which will become a condemnation to men like President Bush. We note that the immediate consciousness raising efforts of Jacques Cousteau are just the beginning of this movement. We mention this because Jacques Cousteau's mission, *to obtain an amendment to the United Nations Charter to protect the rights of future generations*, and ours—which has a political aim—converge, as will be noted in the enclosed *Contract* and its Briefs. Therefore, knowing your age, we hope you will give serious consideration to our point of view and how one who is popular in his own generation will be gravely condemned by the next and—not only this—be remembered as a *fool and an object of scorn*.

Because I know the issues I ask that you also perform an unusual act and appoint me as *Governor of Jerusalem* [temporary, in exile] and demand my full participation in the negotiations. Remember Governor Zerubbabel (re: the book of Ezra; Isaiah 44.28) who is my predecessor? If you appoint me, I will bring the negotiations to a quick settlement. We further *guarantee you* that you will agree with the direction we will take with the negotiations! Even Hashim and David will rejoice! All other efforts will fail.

We hope you can appreciate the significance of the *United Nations Governor of Jerusalem* in participating in the negotiations and the future ridicule it will bring to present leaders if he is not assigned. Recognize also that though aids make decisions for these men, *these men will be ridiculed in the age to come*, not their aids.

We urge you to review our documents which prove our proposal.

Our work offers a *new perspective* which hopefully may be useful as a framework from which new agreements can be reached. These documents have been furnished to the leaders noted below in addition to yourself. We apologize for the bulk. We recommend you read these Briefs first: # 1, 5, 3, 9. These alone will no doubt influence your direction with the Middle East Peace talks.

Re: The Camp David Agreements

Dear President Carter,

As you know it is difficult for an unknown man to break through the barriers of high offices. Though you have reached the highest office in the land—really the world at this time—you have done a most remarkable thing: also reaching down to the lowliest of men, whose cries for help are usually lost midst the pressures of power politics, glory, and money. I applaud you and your wife for your vision and works.

We have prepared a series of documents which may interest you. We don't ask you to read them all at once but would hope that you will read **Brief # 3** which we intend to present along with the other documents to the World Court at the Hague if we are not heard by the United Nations General Assembly. The Brief calls to mind your works in **Waging Peace** and urges the leaders organizing the forthcoming Middle East Conference in October 1991 *to assure that the negotiations are conducted fully under UN Supervision* and including your guidelines. We reminded President Bush to remember the **Rule of Law**—referring to you—because you, President Sadat, and Prime Minister Begin laid the foundation for it in a **New Law**.

You all called upon God many times and your works reflect a dedicated path in pursuing **His Goal** in the Bible. You all latched onto a **Promise of His** and reflected it in the Camp David Agreements. *Continuing in your path* we thought to add one more small reminder to **that Promise**, hoping that the leaders would remember it in their agreements. That Promise is the name **Beulah**, meaning **Married**. We believe the New World—announced by President Bush—will come through **that Marriage** (see enclosures).

Our people will benefit directly from the conclusions reached in the October negotiations, and therefore we seek sponsorship for a presence at the conference. Perhaps—if interested in the Bible's Plan calling forth the **State of Beulah** (**Isaiah 62.4**)—you might provide some guidance on this matter.

We believe that the sure way to bring peace to the Middle East is through the realization of **King Abdullah's dream**, but slightly modified (perhaps you know it). Our claim provides for the creation of a **New Nation**, called **Beulah**, in accordance with **Isaiah 62.4**. It is a place where we can hammer swords into plowshares.

We know you are a busy man and will not impose upon you.

We also know that perhaps our failure to reach the high offices of our nations is due to our inability to express ourselves interestingly, clearly, and concisely. We can't seem to address what people want to hear.

You are a Statesman who was heard: you quoted **Isaiah** and spoke of a reward for *all the Children of Abraham*. The people heading for the October 1991 Conference speak of Arabs, Christians, and Jews. We speak only of the *righteous, the just, and the honest*, (see page 21, **Brief # 3**) and we haven't been able to show anyone how *Our State* is important; and we are each day becoming more nonplussed how we might be heard.

In a Spirit of *fairness and righteousness* we hope you might support the hearing of our *claim* for the New State of **Beulah**—perhaps even sponsor us to the forthcoming October conference. Surely someone ought to be representing us. Time is of the essence for us; we hope we may receive your speedy reply..

Dear Secretary General de Cuéllar ,

It is difficult for an unknown man to break through the barriers of high offices. We hope your secretary can appreciate the problem the *Last Imam* might have if he were to write to World Leaders—as I—concerning his promise of *Unity* and, accordingly, we trust your secretary will make sure this document and its enclosures will be placed into your hands. If not we shall press on with our list of World Leaders until we receive an answer from one who has no shame in hearing us and is sensitive to our problems.

Pursuant to our other documents forwarded to you and other World Leaders, we enclose a *Brief* drawing to the attention of world leaders that the upcoming *conference in October on the Middle East must be conducted fully under UN supervision*. It must also consider *agreements already put on the table* through documents summarized in the enclosed.

My people—who are many—will benefit directly from the conclusions reached in the October negotiations, and therefore we seek sponsorship for a presence at the conference. We trust you received our other documents and hope that you have given them serious consideration.

We believe that the sure way to bring peace to the Middle East is through the realization of *King Abdullah's dream*, but slightly modified. Our claim provides for the creation of a *New Nation*, called *Beulah*, in accordance with Isaiah 62.4. We believe it can be a state which will show an example how men can hammer their swords into plowshares.

In a Spirit of *fairness and righteousness* we hope you might support the hearing of our *claim* for the New State of *Beulah* and review it on the floor of the UN General Assembly; perhaps even sponsor us to the forthcoming October conference. Time is of the essence for us; we hope we may receive your speedy reply..
